For what purpose do we collect, process, and use your personal data?

We process and use personal data for the following purposes:

- Registration and creation of user accounts for the purpose of using computing resources to implement approved projects
- Managing the use of computing resources
- Access to licensed applications
- Access to other services provided by COO SAS
- Creating statistics

Providing personal data to third parties

We do not provide personal data to third parties, except for state administration authorities, courts, and authorities involved in criminal proceedings based on applicable laws. Some anonymized or statistically processed data may be provided to third parties for research and statistical purposes.

Duration of personal data processing

Personal data will be processed during the use of services and computing resources provided by the Center of Shared Activities SAS and subsequently for the administration of projects and grants for the duration of their existence. For internal statistics of computing resource usage, data about projects and user accounts will be processed for at least the duration of the operation of these resources.

Protection of personal data

Personal data is stored in a secure database system. Only authorized administrators have direct access to this system. System administrators of computing resources, as well as other services used by users, also have access to personal data. Some personal data may also be accessed by coresearchers of a user's approved projects.

Rights of data subjects

In accordance with Articles 15, 16, and 17 of the GDPR, data subjects have the right to:

- Free access to stored personal data and information about their processing and use
- Correction of personal data
- Deletion of stored personal data
- Restrict the processing of their personal data
- Withdraw consent for the processing of personal data, in accordance with Article 7 of the GDPR
